

CONSTITUTION OF RAJASTHAN CRICKET ASSOCIATION

Memorandum and Bye Laws

(Registered under the Rajasthan Sports (Registration, Recognition and Regulations of Association) Act, 2005)

PART 'A': MEMORANDUM

ART. 1 Name:

The name of the Association shall be "THE RAJASTHAN CRICKET ASSOCIATION" and it shall be hereinafter referred to as the "Association".

ART. 2 Registered Office:

The registered office of the association shall be in the State of Rajasthan at such a place as decided by the General Body of the Association.

ART. 3: Jurisdiction:

The Jurisdiction of the Association shall extend to the geographical limits of the State of Rajasthan. The Association shall be affiliated to the Board of Control for Cricket in India.

ART. 4 Constitution:

Raiasthan Cricket Association

"Rajasthan Cricket Association" shall have a written constitution and shall be the supreme law of Rajasthan Cricket Association. All activities of the Rajasthan Cricket Association shall be governed by its Constitution and all regulations and orders passed by the Rajasthan Cricket Association shall be in conformity with the provision of the Constitution. Subject to the provisions of the Rajasthan Sports Act 2005, any regulation inconsistent with the provisions of the constitution of Rajasthan Cricket Association shall

be illegal and void to the extent of such inconsistency.

ART. 5 Aims and Objects:

The Association shall be the governing body of the game of cricket in the State and its objects shall be to advance and safeguard the interests of the game of cricket and particularly:

- 1. To promote, organize, manage and control the game of Cricket within its jurisdiction;
- 2. To control and improve quality and standards of the game of Cricket in Rajasthan, lay down policies, roadmaps, guidelines and make rules and regulations (and amend or alter them) in all matters relating to the game of Cricket, recognizing that the primary stakeholders are the Players and Cricket fans in Rajasthan, and that accountability, transparency and purity and integrity of the Game are the core values;
- 3. To provide for measures necessary for promotion and development of the game of Cricket in Rajasthan, welfare and interest of Cricketers and elimination of unethical and unfair practices in the Game of cricket in Rajasthan; and for that purpose, organize coaching schemes, establish coaching academies, hold tournaments, exhibition matches, Test Matches, ODIs, Twenty/20, T-10 and any other matches and take all other required steps;
- 4. To strive for sportsmanship and professionalism in the game of Cricket and its governance and administration; inculcate principles of transparency and ethical standards in players, team officials, umpires and administrators; and to ban doping, age fraud, sexual harassment and all other forms of in-equality and discrimination;
- 5. To select team's to represent the Association in any tournament, championship or fixture, local or otherwise, and to incur and pay

the expenses thereof;

- 6. To arrange proper coaching camps for the benefit of cricketers, to provide suitable coaches and to acquire and maintain playgrounds and cricket nets etc. either directly or through District Cricket Association etc.;
- 7. To maintain a general control of the game of cricket under its jurisdiction and take decision in all matters concerning the game either when referred to by affiliated association or suo motu;
- 8. To maintain a library of books, periodicals and publications on sports in general, and cricket in particular, and to diffuse knowledge of cricket and ideals of sportsmanship;
- 9. To encourage the game of cricket and foster the spirit of sportsmanship in students of schools, colleges and universities and members of affiliated units and thus enable them to develop good physique and good standard of the game;
- 10. To encourage the formation of District Cricket Association in such areas of Rajasthan as the Association may deem fit (District as per Government Rules);
- 11. To acquire by all lawful means, movable and immovable properties on behalf of the Association and to sell, manage, hire, lease out, exchange, dispose of or otherwise deal with all or any of its properties and/or any income accruing therefrom;
- 12. To purchase, take on lease or otherwise acquire any ground or building and to lay out such ground or any other ground for playing the game of cricket and for other purposes of the Association and to provide pavilions, stadiums, dressing and refreshment rooms and such other amenities in connection therewith, as may be necessary or expedient;
- 13. To collect funds and to utilize the same as well as the other funds in such manner as may be considered for fulfilment of the Aims

and objects of the Association;

- 14. To maintain a panel of approved cricket umpires and coaches and to take all such steps as may be necessary for efficient umpiring and coaching;
- 15. To take such action as may be necessary to coordinate the activities of Association/affiliated units and their members in relation to the Association and amongst themselves;
- 16. To arrange, stage, participate in any match of cricket for the benefit of any cause as the Association may deem fit;
- 17. To stage matches and to subscribe income to funds for philanthropic purposes i.e. for helping a disabled and/or ailing player, of any game, athlete or any other deserving individual, for relief of a person, localities village/villages, town suffered from natural calamities like flood, famine, fire etc.;
- 18. To award scholarships to needy and promising young cricketers;
- 19. To stage or organize Test and/or other matches, official or unofficial, allotted to the Association by the Board of Control for Cricket in India or by any other body controlling cricket in India as the Association may deem expedient and, on such ground/field as the Association may deem fit or expedient;
- 20. To appoint representative or representatives of the Association in the Board of Control for Cricket in India and in other conferences, seminars and workshops connected with the game of cricket,

21. To employ and appoint CEO professional managers, auditors, executive secretaries, administrative officers, assistant secretaries, managers, clerks team support staff, players and other service personnel and staff and to pay to them for their services rendered to the Association by way of salaries, wages,

- gratuities, pensions, honorarium, compensations, any ex-gratia payments and/or provident fund and to remove/terminate or dismiss such employees or personnel;
- 22. To receive monies and donations from any person/s clubs, associations or institutions and to utilize and/or invest the same in any manner and for any purpose as per the decision of the Executive Committee;
- 23. To give financial assistance to the members District for such purposes as may be decided upon by the Association from time to time;
- 24. To invest monies and funds of the Association in authorized securities or in any way and manner as may be decided upon from time to time;
- 25. To maintain and enforce the spirit of impartiality in formation of committees, selection of players of the team/teams, places to stage the matches, delegation of powers to the functionaries of the association, and investment of association funds. Considerations on the basis of regions etc. will be totally discouraged;
- establish/maintain harmony of relationship with Rajasthan State Sports Council, Central and State Ministries of game and sports, with other related institutions and persons;
- 27. To engage persons as professional cricketers and to pay remunerations or honorarium to them, if necessary;
- 28. To frame, add, delete, alter, maintain and enforce rules for the control and governance of the game under its jurisdiction and to maintain discipline amongst players, officials and districts under its jurisdiction;

29. To constitute committees, from time to time, and entrust or delegate its functions and duties to such Committees, for achieving

- 30. To lay out cricket grounds and to provide pavilion, canteen and other facilities and amenities for the convenience and benefit of the members, players, and the Cricket fans including the women and the disabled, and to ensure the availability of Cricket gear and amenities to Cricket players;

To encourage the sports and sports persons of every section of society without any discrimination and generally to do all other acts, deeds, matters and things as are incidental to the objects of the association or as the association may deem conducive to the attainment of the objects specified above;
- 32. To encourage the development of District Cricket Associations; and the organisation of Inter-District, State level and other Tournaments; to lay down norms for recognition which achieve uniformity in the structure, functioning and processes of Member Associations;
- 33. To select teams to represent Rajasthan in Test Matches, Any Day Matches, One Day Matches, Twenty/20 Matches, T-10 Matches and in any formation India or abroad as the BCCI may decide from time to time;
- 34. To promote, protect and assist the Players who are the primary agents of the game by:
 - (i) Creating a Cricket Players Association of Rajasthan to be funded by the RCA;
 - (ii) Being sensitive to Player's before domestic calendars are drawn up so that sufficient time is provided for rest and recovery;
 - (iii) Taking steps, particularly on longer tours, so the emotional wellbeing and family bonds of the Players are strengthened;

PART 'B' - BYE LAWS

Interpretation:

Unless there is anything repugnant to the context or subject or words imparting masculine gender shall include feminine and singular number shall include plural and vice versa.

Art. 6. Definitions:

In these bye-laws, unless the context otherwise require: -

- (1) "Apex Council" means the principal body of RCA tasked with its governance, and also known as the "Executive Committee";
- (2)"Association" shall mean the Rajasthan Cricket Association;
- (3)"Auditor" is the Auditor of RCA appointed by the General Body/Apex Council of the RCA to discharge the audit functions;
- (4)"Board" shall mean the Board of Control for Cricket in India which is the National affiliating body of the Rajasthan Cricket Association:

"CEO" is the Chief Executive Officer of the RCA appointed by the Apex Council for a term of 2 years, and extendable by one more year as set out in Article 43;

- (7) "Councillor" shall mean a member of the Apex Council/Executive Committee;
- (8) "Cricket Players' Association" is the Association of Players so as per the BCCI Constitution;
- (9) "Domicile of State of Rajasthan" means a person who has been ordinarily resident in Rajasthan for at least 10 years and his name is included in the Election Commission of India voters' list in Rajasthan;
- (10) "District Members" shall mean any of the District Cricket Association of Rajasthan State which is an affiliated member of the Association (District as per Government Rules);
- (11) "Electoral Officer" is the person appointed to conduct, supervise and deal with issues concerning elections as set out in Art 20;
- (12) "Ethics Officer" is the person appointed to administer the conflict of Interest Principle as set out in Article 50;
- (13) "Game" shall mean the game of Cricket;
- (14) "General Body" shall mean and include all voting and non-voting members of the Association;
- (15) "General Meeting" shall mean and include Annual General Meeting or any Extraordinary General Meeting;
- (16) "Hony. Secretary" means the Hony. Secretary duly elected by the General Body and shall include a Joint Secretary;
- (17) "Hony. Treasurer" means the Hony. Treasurer duly elected by the General Body:
- (18) "Members" shall mean and include all voting and non-voting members such as District Associations, Former International Players, Patron, and Vice-Patron, Life and Ordinary Honorary Members;

- (19)"Office Bearers" mean and include the elected President, Vice President the elected Hony. Secretary, elected Hony. Joint Secretary and the elected Hony. Treasurer;

- (22)"Ombudsman" is the independent grievance redressal authority set up under Article 46;

- (25)"President" shall mean the President of RCA duly elected by the General Body;

"RSSC" shall mean the Rajasthan State Sports Council which is the legal affiliating body of RCA;

- "RCA" shall mean the Rajasthan Cricket Association; (27)
- "Rajasthan" shall mean and includes all territories under the (28)administrative control of the Government of Rajasthan;
- (29)"Regulation" shall mean executive instruction sanctioned by the Executive Committee:

"Representative" of a member shall mean a person duly

- "Special Resolution" means a resolution passed by 2/3rd (31)majority of voting members present and voting in General Body meeting the minutes of which meeting are recorded and signed by the office bearers and attested by the Observer, if any, present. At least half of the total number of voters shall constitute a quorum for this purpose;
- (32)"Sub-Committee" shall mean sub-committees as may be nominated by the General Body of the Association for purposes as may be deemed necessary;
- (33)"Team Official" refers to the support staff appointed by the Association including coaches, managers, physiotherapy, nutritionists, trainers, analysts, counsellors, medics and any other personnel to assist the team;
- (34)"Vice President" means the Vice President duly elected by the General Body.
- (35)"Year' shall mean the affiliation year of financial year viz 1st April to following 31st March;

Note: All the definitions given in the Act and rules shall apply.

Art. 7. Memberships:

The Association shall consist of the following members;

(A) Voting Member:

- (1) Member District Cricket Association, which is duly registered under the provisions of the Rajasthan Sports Act 2005 and complies with the conditions of affiliation with RCA.
- (2) Former International Players (male and female) hailing from Rajasthan;
 - (a) Any District Cricket Association which in the opinion of the Executive Committee, if eligible for

admission as a member, may be enrolled as such on payment of such fees as may be prescribed by the Executive Committee from time to time.

(b) Duly elected Hony. Secretary of District Cricket Association shall be eligible to attend, speak and vote in the annual and all other General Body Association without meeting of the authorization letter. In case Hony. Secretary of any District Cricket Association is unable to participate or Executive Committee of that District resolves to send any other Executive Committee member for the meeting then that duly elected Executive Committee Member may represent that District in the annual or any other General Body meetings of the Association. Authorized Executive Committee member should bring letter authorization duly signed by the President, Hony. Secretary and the Treasurer along with a copy of resolution duly signed by the Hony. Secretary of the District Cricket Association.

District Cricket Association shall immediately send the audited Balance sheets and Profit and Loss accounts by 15th September of each year and on being asked for by the Association. They shall intimate any change to the Association immediately, and shall keep the Association informed of their activities from time to time. They shall also, inform the Association whenever elections are being held as per their constitution and Apex Council shall send an observer for such

meeting and if the Association is not informed of such a meeting, the Association may inform and declare such meeting null and void and ask the District Members to hold election afresh.

- (d) The General Body meeting is empowered to prescribe procedure and make regulations for admission and may at its discretion for membership of the association and shall not be bound to give reasons for rejections.
- (e) Where disputes are pending regarding the duly recognised district association to represent a particular District, the District shall be represented by the recognised Association, subject to any order of the Court or resolution of the RCA as the case may be.
- (f) Notwithstanding anything contained above, all Former International Players (male and female) hailing from Rajasthan, provided he/she has not already opted for membership of another association, shall be granted automatic membership in the Association. Such Former International Players will be entitled to all rights and privileges of membership, including the right to attend, speak and vote at meetings of the General Body They shall also be eligible to be an Office Bearet of the Association, subject to fulfilling as per Art. 26. The Former qualifications International Players will not be liable to pay any admission or subscription fees.

(B) Non-Voting Members: Patron, Vice Patron, Life Member and Ordinary Members:

(a) Patron Members:

The Executive Committee may invite from time-totime distinguished person/persons to be Patron Member of the Association on payment of the prescribed fees as fixed by the Executive Committee from time to time.

(b) Vice Patron Members:

The Executive Committee may invite from time-totime distinguished person/persons to be Vice Patron Members of the Association on payment of the prescribed fees as fixed by the Executive Committee from time to time.

(c) Life Members:

Any individual, who has completed his age of 21 years, desires to become a Life Member of the Association shall, on approval of the Executive Committee and on payment of the prescribed fees as fixed by the Executive Committee from time to time, be enrolled as a life Member on receipt of the stipulated membership fee.

(d) Ordinary Members:

Any individual may be enrolled as an ordinary member of the Association subject to the approval by the Executive Committee and payment of such fees as may be prescribed by the Executive Committee from time to time. The number of such members shall not exceed 25.

(e) Honorary Members:

The Executive Committee may invite from time to time as Honorary Member/ or Members any person or persons of distinction who is interested in the game of Cricket or who has rendered meritorious services relating cricket game and who is/are in a position to act certain occasion in an advisory capacity;

- (e) The following Office Bearers of the Association shall be elected by the Voting Members of the Association at an Annual General Meeting:

The elected President, elected Vice President, the elected Hony. Secretary, elected Hony. Joint Secretary and elected Hony. Treasurer.

- The Executive Committee (Apex Council) shall comprise of 9 Councilors of whom 5 shall be the elected Office Bearers and the remaining 4 shall be:
- (1) One Executive Member to be elected by the Voting Members of the Association;
- (2) Two, one male and one female, to be nominated by Cricket Players' Association from amongst those of its members who hail from Rajasthan;

Art. 24. No Confidence Motion:

The General Body in its meeting by a resolution if passes a noconfidence motion against any of the office bearers or Councilors such office bearer or Councilors shall cease to hold office in association immediately after such resolution is passed. However, such resolution must be passed by 3/4th majority of voting members present and voting in General Body meeting and the minutes of which meeting are recorded and signed by the office bearers and attested by the Observer, if any, present. At least 2/3rd of the total number of voters shall constitute a quorum for this purpose. (Subject to Sports Act 2005).

Art. 25. Tenure of Office:

Office bearers and the Councilors of the Association will hold office for one term of three years and after expiry of that period until their successors are appointed. Art. 26. Qualification / Disqualification:

(ii) They are ordinarily resident in the District, or

- (D) An Office Bearer or an elected Councilor who has held any post for two consecutive terms either in a state association or in the BCCI (or a combination of both) shall not be eligible to contest any further election without completing a cooling off period of three years. During the cooling off period, such an office bearer or a Councilor shall not be a member of the Governing Council or of any committee whatsoever of the BCCI or of a state association. The expression 'Office Bearer' or 'Councilor' should not be permitted to be circumvented by being a member of any other committee or of the Governing Council in BCCI or any state association, as the case may be.

- (C) For allowing any Cricket event involving other States players or exhibition matches or any other event requiring permission from RCA or BCCI, to be held by any of its affiliated clubs or institutions without prior approval of RCA.
- (D)In case of District Cricket Association, for not sending their District Team if any of the State Championship (Senior and Junior) continuously for two years. Art. 32. Re-Admission:

Art. 33. Obligations of Players:

The Executive Committee has full power to suspend and take disciplinary action against any player who fails to comply with any of the following:-

- (a) A player shall observe discipline and obey the regulation laid down by the State Association especially in tournament organized by the State, which impedes the smooth functioning of any activity of the State Association.
- (b) A player must at all times accept the authority of the Association. He shall place himself at the disposal of the Association when required to be prepared for a take part in event for which he may be selected to represent his State or Country. If he declines without good reason to place himself at the disposal of the Association, he shall render himself to be suspended.

- (d) A player shall not play in a tournament, match or other competition in public, which is not controlled by an authority approve by the State Association of that State in which the event is held.
- (e) BCCI rules will apply to all the players playing in Rajasthan.

Art. 34- Vacancies:

- (a) If there is any vacancy in the Executive Committee due to resignation, death, insolvency, unsoundness of mind, nomination to the BCCI or recall or any other reason of an Office Bearer or an elected Councilor, the General Body is authorised to fill in the vacancy during its tenure through election but only for balance tenure. In the case of a nominated Councilor, in the same manner as prescribed for the respective nominee in Art. 8(f) and 17(A).
- (b) Any Office bearer or Councilor who has assumed office by virtue of having filled a permanent vacancy shall not be entitled to have a full term but would enjoy only the balance term.
- (c) "Resignation" may be accepted by the President after consultation with the Executive Committee.

Art. 35- Alteration in the bye-laws:

No alteration of Bye-Laws shall be made except an annual General Body Meeting or extra ordinary general meeting by a special resolution as defined in the Ordinance/ Act and carried by a majority of at least 2/3rd of the votes properly recorded at the meeting. Any alteration so made shall come into effect immediately. Proposal for any change in the Bye-laws of the Association for consideration at the AGM must reach to the Hony.

Art. 36. Saving Clause:

Any point not directly covered by these Bye-Laws shall be decided in the light of the Bye-Laws most nearly applicable and in accordance with the general tenor and spirit of the said Bye-Laws by the President. He would place such matters in the next meeting of the Executive Committee for confirmation.

Art. 37. Patron in Chief & Patron:

Any person of repute who has rendered extra ordinary services for the development of game of Cricket in state may be elected Patron-in- chief/patron of the Association, or may be designated as "Hony. Chairman/Chairperson". These would-be Honorary position for giving an honour to the person and shall be outside the Executive Committee without any voting right.

Art. 38 Sanction for Open Tournament:

- (a) Sanction to hold an open tournament invitation or international tournament shall only be granted to affiliated organization and to primary sports bodies affiliated to such organisations.
- (b) No tournament shall be held in Rajasthan without the permission of the RCA.
- (c) The penalty for both players and the primary sports bodies which has conducted the unauthorized tournaments shall be, as decided by RCA.
- (d) No permission to hold a new tournament shall be granted and sanctioned without reference to the affiliated

- (e) If any such tournament is proposed to be held within whose jurisdiction without permission that will be declared void and unauthorised.
- (f) The designation of an open tournament shall be determined by RCA.
- (g) No prize is to be offered for junior event conducted by either at National or State Level.

A. Permission to conduct tournaments

- No Club affiliated to a member shall conduct or organize any tournament or any matches in which payers/teams from the region within the jurisdiction of a member are participating or are likely to participate without the previous permission of the member affiliated to the RCA.
- No member or a Club affiliated to a member shall conduct or organize any tournament or any match/matches in which players/teams from regions outside their jurisdiction are participating or are likely to participate without the previous permission of the RCA.
- 3. Permission from conducting or organizing any tournament or any match/matches will be accorded only to the members of the RCA and will be in accordance with rules framed by the RCA in this regard from time to time.
- 4. No member of a club affiliated to a member shall conduct or organize any international tournament or international match/matches in which foreign players/teams or players/teams from other State are participating or are likely to participate without the previous permission of the BCCI and the RCA.

B. Ban on participation in unapproved tournaments

- 1. No member shall participate or extend help of any kind to an unapproved Tournament.
- 2. No player umpire, Scorer, Official or other person associated the RCA shall participate in any unapproved tournament.
- 3. The Apex Council shall take appropriate action including suspension and stoppage of financial benefits and any other action against individuals / members contravening the above.

Art. 39 Right of Appeal.

Any primary sports bodies or player or person being aggrieved by a decision or ruling of an affiliated organisation may appeal to RCA within a period of thirty days of the said decision or ruling and the appeal shall be heard at such place and time and such person and in such a manner as the Hony. Secretary of the Association shall inform as per decision of Executive Committee.

Art. 40: Arbitration

In case any dispute between RCA and its Constituents/members is not resolvable by an appeal to the General Body or the affected party is still aggrieved, and does not want to go to the Ombudsman, the matter would be referred for arbitration. The Arbitration Proceedings shall be under the Arbitration and Conciliation Act, 1996 consisting of the following:

- A Legal Authority nominated by the President. 1.
- A Legal Authority nominated by the Secretary which is 2. mutually acceptable.
- 3. A legal Authority nominated by the General Body or its delegate. Provided that President after consultation with Executive Committee may appoint a sole arbitrator instead of a panel of three.

Art. 41: Representation:

Rajasthan Cricket Association can sue and be sued through designation of its Hony. Secretary and in the absence of Hony. Secretary by designation of Joint Secretary nominated by the General Body or President for the time being as "Acting Secretary".

Art. 42 Accounts Audit and Inspection:

The accounts, audit, returns and inspection of the record shall be governed by regulations framed by the Apex Council.

Art. 43. The CEO:

- (1) The day-to-day management of the affairs of the RCA shall best in a full time CEO to be appointed by the Apex Council, who shall be a management professional with management experience of at least 5 years as the CEO/MD of a company with a turnover of at least Rs. 5 Crores.
- (2) The CEO shall be assisted by not more than 3 full-time professionals (Managers) who shall be appointed by the Apex Council in consultation with the CEO essentially to govern the streams of finance, technical, infrastructure, law, media and human resources. The CEO may however realign or reallot these streams as he deems fit.
- (3) The eligibility criteria for the CEO and Managers shall be laid down by the Apex Council keeping in mind the following guidelines:
 - (a) Knowledge and familiarity with cricket or other sports;
 - (b) Understanding of financial position and fiscal direction of the RCA;
 - (c) Knowledge of operations of cricket administration and overall policy;
 - (d) Clarity on role, division of responsibilities and hierarchy; and;
 - (e) Familiarity with regulatory and legal responsibilities as well as attendant tisks.

There shall be an appropriate induction process laid down by the Apex Council for the CEO and the Managers, which shall include a fair and transparent process of appointment.

Art. 44: The Functions of the CEO:

The CEO shall have the following functions on behalf of the RCA:

- (2) To issue guidelines in respect of travel, accommodation, allowances, etc., to be paid to players, support staff and officials participating in matches, other than international matches.
- (3) To lease and manage immovable property of the RCA wherever situated, in order to promote the objects of the RCA.
- (4) To lay down parameters for the laying of grounds for playing the game and to provide pavilion, canteen and other conveniences and amenities in connection therewith.
- (5) To appoint Team Officials for the State teams which shall compulsorily include qualified coaches, managers, physiotherapists, nutritionists, trainers, analysts, counsellors and medics
- (6) To secure Players' welfare to ensure that the logistics manager will arrange for accommodation and travel, to ensure that tickets given to Players for matches will be on par with those given to the Members, and to also ensure that no expenditures towards the game (baggage handling, injury related, atc.) will be undertaken by the Player, failing which such expenses will be reimbursed to the Player within 30 working days of the requisition being made.
- (7) To ensure that all measures are adopted to eliminate any form of facial, communal, castiest or other hatred from the game, with stringent action taken against the offenders including the initiation of criminal proceedings.
- (8) To start and maintain a library of books, periodicals, DVDs and other databases on Sports in general and Cricket in

- particular, and to publish journals, books and other material as well as the official website of the RCA.
- To produce by itself the Cricket content for telecast of (9)cricket matches and/or ceremonies by hiring or owning equipment and hiring necessary crew, technicians, etc.
- (10) To publicize the stadium capacity of all stadia across the State with compulsory seat numbers, to provide transparent online and offline ticket booking services with reasonably priced tickets and maximize the access of the public to the games.
- (11) To provide at stadiums, wholesome and hygienic food and beverages at affordable rates, dean and hygienic restrooms for all genders and for the differently-abled, adequate fire and emergency entries and corridors, sufficient access avenues and wheelchairs for the differently-abled, proper signage, parking and transport facilities as well as efficient security systems.
- (12) To arrange and organize the National Championship of India for the Ranji Trophy matches or for University, Schools or other tournaments or for any Exhibition matches between members and / or between the Universities in India including regulations and bye-laws in respect of travel, accommodation, allowances to be paid to players and officials participating in such matches on behalf of RCA.

To frame guidelines generally for the convenience and ease of day-to-day management of affairs of the RCA.

(14) To prescribe guidelines to lay out or convert any ground into high quality turf wickets at all levels in all areas of the State and provide Pavilions, Canteens, Conveniences and other amenities with disabled access and

- (15) To assist the Cricket Committees and facilitate the implementation of their tasks and recommendations.
- (16) To collate monthly reports concerning the functioning of the various Committees, to create action plans in advance and upload the same on the website of the RCA.
- (17) To create a database of all cricketers at all levels, maintain records and statistics, track performances and certify age and identity of participants.
- (18) To take steps to create world class infrastructure at all levels in all areas across the State. To coordinate with District associations, to conduct tournaments, to provide better access to the public, with particular reference to women and the disabled.
- (19) To put in place mechanisms to encourage Rajasthan cricketers to play nationally/ internationally and hone their skills so that a wider talent pool is available to represent the country/the State.
- (20) To sign and enter transparently into contracts for and on behalf of the RCA including with third parties and vendors for the purposes of the various Committees of the RCA, and to ensure that in all contracts for television and media rights, the interests of the public remain uncompromised, and full, unhindered broadcasts of all deliveries and their replays are shown.
- (21) To report to the Apex Council every quarter or as often as required by the Apex Council on the functioning of the management and the progress made in developing cricket in

- (22) To consider the reports of the Auditor, to verify whether Members are meeting their objectives and to assess whether cricket is being suitably developed and promoted across the State.
- (23) To consider all applications for financial aid or any other benevolence to Cricketers, Umpires and other Officials as per the rules framed by the General Body in this behalf from time to time and recommend the same to the Apex Council for their approval.
- (24) To examine all the expenditure exceeding the Budget and to control such outlays as are required for the proper administration of the RCA.
- (25) To advise the RCA regarding investments.
- (26) To process requests made for increase in all types of allowances, subventions/subsidies to be paid to the Associations, tariff for Coaching Camps, Coaching Subsidies to the Associations, allowance to the players for matches of different Trophies and when playing both at home and away and to recommend the same to the Apex Council.
- (27) To do all acts and things which are delegated by the RCA and Apex Council to him, and all other functions as are necessary and expedient to carry out the objects of the RCA as aforesaid including carry on correspondence in the name of the RCA.

Art. 45: The Auditors:

(1) The General Body shall at every Annual General Meeting appoint one or more auditors to hold office for a 1year period and shall fix their remuneration. The Auditor shall be

- (2) The Auditor(s) of the RCA shall have the right of access at all times to the Books of Accounts, Vouchers and any other documents relating to the accounts of the RCA and shall be entitled to obtain from the Office-Bearers and Committees such information and explanation as may be necessary in the discharge of his/their duties.
- (3) The Auditor(s) shall provide an opinion on the financial statements of the RCA and recommendations on the financial controls within the system, which shall be contained in a Financial Report.
- (4) The Auditor(s) shall also ascertain how the funds of the RCA are being utilized by the respective Members. It will be the responsibility of the Auditor(s) to verify the statements made by the Member associations in this regard and to give findings, which shall be contained in a ComplianceReport.
- (5) Both the Financial Report and the Compliance Report of the Auditor(s) shall be considered at the Annual General Meeting.

Art. 46. Ombudsman:

Art. 47. Grievance Redressal:

(1) The types of disputes/ differences that form the Ombudsman's ambit and the procedures for redressal are:

(a) Member, Association & Franchisee Disputes

Any disputes between or among the RCA, its Members, Franchisees, and the Cricket Players' Association shall be automatically referred to the Ombudsman.

Procedure: Both parties would submit their arguments and a hearing would be conducted following the principles of natural justice and exercising all powers of enquiry and hearing as the Ombudsman deems fit before appropriate orders are passed.

(b) <u>Detriment caused by Member or Office Bearer;</u>

If any Member or any Office Bearer of the RCA commits any act of indiscipline or misconduct or acts in any manner which may or likely to be detrimental to the interest of the RCA or the game of cricket or endanger the harmony or affect the reputation or interest of the RCA or refuses or neglects to comply with any of the provisions of the Memorandum and/or the Rules and Regulations of the RCA and/or the Rules of conduct framed by the RCA, the Apex Council, on receipt of any complaint shall issue a Show, Cause Notice calling for explanation and on receipt of the same and/or in case of no cause or insufficient cause being shown, refer the same to the Ombudsman. The Apex Council may, if it considers appropriate, suspend such a Member, Player, or Office

Procedure: The Ombudsman shall, after providing opportunity of hearing to the parties concerned, pass an appropriate order.

(c) Misconduct or Breach by Others

In the event of any complaint being received from any quarter or based on any report published or circulated or on its own motion, of any act of indiscipline or misconduct or violation of any of the Rules and Regulations by any Player, Umpire, Team Official, Selector or any person associated with the CA, the Apex Council shall refer the same within 48 hours to the CEO to make a preliminary enquiry.

Procedure: The CEO shall forthwith make a preliminary inquiry and call for explanations from the concerned person(s) and submit his report to the Apex Council not later than 15 days from the date of reference being made by the Apex Council. On receipt of the report, the Apex Council shall forward the same Ombudsman, who shall call for all particulars and unless it decides that there is no prima facie case and accordingly drops the charge, hearing shall commence on the case and the same shall be completed as expeditiously as possible by providing a reasonable opportunity to the parties of being heard. If, despite due notice any party fails to submit any cause or submits insufficient cause, the Ombudsman shall after providing reasonable opportunity of hearing to the parties concerned, pass appropriate order. any party refuses and or fails to appear despite notice, the Ombudsman shall be at liberty to proceed ex-parte on the basis of the available records and evidence. Upon a reference being made, the President may place such a person under suspension till final adjudication by the Ombudsman.

(d) By the Public against the RCA

Where a member of the public 1s aggrieved concerning ticketing and access and facilities at stadia, the same may be brought in the form of a complaint to the Ombudsman.

Procedure: The Ombudsman would adopt the same procedure as laid down in (c) above after referring the complaint to the CEO to solicit a report on the complaint.

- (2) The place of hearing shall be decided by the Ombudsman from time to time. The Ombudsman shall have the power to impose penalties as provided in the Regulations for Players, Team Officials, Administrators, Managers and Match Officials of the RCA.
- (3) The decision of the Ombudsman shall be final and binding and shall come into force forthwith on being pronounced and delivered.
- (4) That the Apex Council may refer any dispute to the Ombudsman.

Art. 48. Transparency:

(1) The Memorandum of Association, Rules and Regulations and all other resolutions, orders and memoranda of the RCA (including Apex Council and the General Body) shall be freely

- (3) All payments and expenditures made by the RCA which is in excess of Rupees Twenty-Five Lacs shall be enumerated and uploaded on the website.

Art. 49: Conflict of Interest:

- The Provision of Rules 38 (1) to 38 (5) of the BCCI Constitution (1)shall apply mutatis mutandis to the Association.
- (2)Within a period of 15 days of taking any office under the RCA, every individual shall disclose in writing to the Apex Council and existing or potential event that may be deemed to cause a Conflict of Interest, and the same shall be uploaded on the Website of the RCA. The failure to issue a complete disclosure, or any partial or total suppression thereof would render the individual open to disciplinary action which may include termination and removal without benefits. It is clarified that a declaration does not lead to a presumption that in fact a questionable situation exists, but is merely for information and transparency.
- (3)A Conflict of Interest may be either Tractable or Intractable:
 - (a) Tractable conflicts are those that are resolvable or permissible or excusable through recusal of individual concerned and/or with full disclosure of the interest involved.
 - (b) Intractable conflicts are those that cannot be resolved through disclosure and recusal, and would necessitate the removal of the individual from a post or position occupied so that the conflict can cease to exist.

Explanation: if the wife held 51% shares, the conflict will be treated as intractable. If the wife holds 3% shares, whether the conflict is tractable or intractable will have to be decided by the Ethics Officer on the facts of the case. If the wife holds only 100 shares out of 1 crore shares, a disclosure of the same may be sufficient.

- (A) Conditions for affiliation of District Cricket Association.
 - (1) District Cricket Association shall be a body duly recognized by Rajasthan Cricket Association and with a certificate of affiliation issued with the seal of Hony. Secretary, Rajasthan Cricket Association, and Copy of the minutes of Executive Committee for such recognition.
 - (2) Each affiliated District Association shall consist of Minimum Five clubs and any addition or deletion in the club or any change in the Executive Body/Committee of the Club shall be intimated to the Rajasthan Cricket Association within seven days of such change with the relevant supporting documents
 - (3) The Executive Committee of District Cricket Associations should be elected in the Annual General Meeting of the Association for maximum term of four years. Any change thereof shall be intimated to the Rajasthan Cricket Association within seven days by submitting all the relevant documents.
 - (4) District Cricket Association and their Primary Sports Bodies/Clubs shall be bound to follow the provisions of the Bye-Laws of the Rajasthan Cricket Association
 - Each affiliated District Cricket Association should submit its annual return by and before 30th September of each year in which names of all affiliated clubs and institutions shall be mentioned.

Any duly elected office bearer of any affiliated Primary Sports Body/Club is qualified to contest elections for the Executive Committee of District Cricket Association if:

- 1. (i) They have born in the district, or
 - (ii) They are ordinarily resident in the District, or
 - (iii) They possess property in the District, or
 - (iv) They are working in the District.
- 2. They are Indian Citizen and Domicile of State of Rajasthan.
- They have not been convicted for any criminal offence.
- 4. No Charges have been framed against them in any criminal case. This is to mean that there is no formal order of framing of charges against them.
- (13) The failure to follow any of the above conditions by the District Cricket Association would result into automatic disaffiliation of that District Cricket Association membership from Rajasthan Cricket

SCHEDULE- D

Bye laws which are mandatory for District Cricket Association to incorporate in their Constitution: -

- 1. Each affiliate District Cricket Association shall consist of Minimum five clubs and any addition or deletion in the club or any change in the Executive Body/Committee of the Club shall be intimated to the Rajasthan Cricket Association within seven days of such change with the relevant supporting documents
- Each affiliate District Cricket Association should form its own bye-laws regarding affiliation of clubs in those districts and the same shall be consistent to the bye-laws of the Rajasthan Cricket Association
- No individual has any voting rights in the Association. Any association having such rights will automatically stand disaffiliated from RCA.
- Corporate Bodies or Business Houses can get affiliated to District Cricket Association but will not having any voting rights.
- Every District Cricket Association affiliated to RCA may get itself affiliated to District Sports Council.
- 6. Every District Cricket Association should incorporate the following objects in its constitution.
 - a. To promote and develop the game of cricket within its jurisdiction.
 - To make, vary, alter, maintain, and confer Bye-laws and regulations, for the control and governance of the game.

- c. To uphold and maintain the Bye-laws and regulations, for the time being in force, of the Rajasthan Cricket Association.
