FINANCIAL BID

CONDITIONS FOR RPL T-20 TOURNAMENT COMPRISING OF 34 MATCHES TO BE PLAYED AT JAIPUR AND JODHPUR:-

1. The bidder will only have right to retain the following revenue :-
 - (i) Advertisement inside and outside the ground.
 - (ii) Sponsorship of the tournament which would be procured and collected by the bidder only.
 - (iii) The revenue from ticketing of the 60% of total seats (Block wise) will be direct revenue of the bidder.
 - (iv) Other residual income / other misc income (Except specified revenue which would belong to RCA and Franchisees) as may be directly collected by the bidder will also belong to the bidder.
2. That the bidder will be responsible to incur and pay for all expenses for the one complete season for RPL as specified in the tender document and addendum thereto.
3. After considering the above, the net amount to be paid by the bidder to RCA + GST at the applicable rate is to be quoted as financial bid for one year of one complete season. Minimum bid amount would be Rs. 1.50 Crore per annum.
4. The bidder who offers the highest license fees will be selected as highest bidder.

5. The bidder has to quote as under :-

Note :

1. Fee shall increase by a minimum of 10% or increase upto 60% of WPI index as published by RBI, calculated as at the date of award of contract and at the end of 3 year.
2. 25% of the bid amount would be payable within 7 days of the award of the contract along with bank guarantee for the remaining 75% amount which will be released or payment of the amount. The remaining 75% amount would be payable within 7 days of the close of the tournament final match.
3. The above Financial Bid will remain in force till the total number of teams remain 6. In case of increase of number of teams, the fee as above will be increased by 25% of the proportionate increase in the number of teams.
