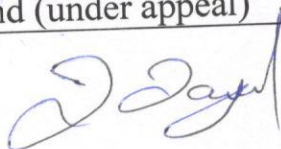
1. The financial statements are subject to Statutory Audit in terms of the constitution of the Association.

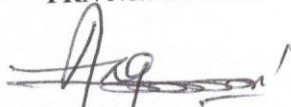

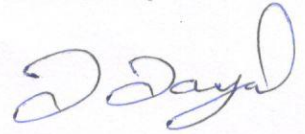
